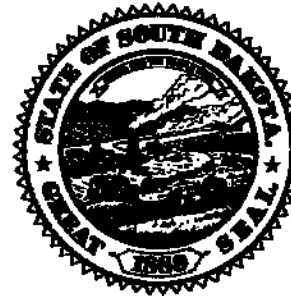

The licensed products available through this agreement must be **ORDERED DIRECTLY FROM SOFTWARE HOUSE INTERNATIONAL** with credit card or purchase order.

First time purchase order requests need additional information to set up accounts and billing procedures.

***** NOTE *** Software licenses DO NOT include installation software or manuals. Both must be ordered separately.**

For Non-Standard software licenses select the Non-Standard Licenses & Media Price Listings XLS located on the State Contracts Listing.

Ordering Instructions for State of South Dakota Public Universities & Regental Institutions:

The licensed products available through this agreement must be ordered through the normal requisition process as directed through the Office of Procurement Management.

The item numbers assigned to these products have been defined with default information. When adding a requisition line (RQ1 Screen), you need not fill in the BUYER ID, UNIT PRICE, PAY ENTITY, or the VENDOR NO. Fields. These fields will carry forward when you press Enter to save the requisition line.

When ordering, Media please use commodity code: **20556** (includes CDs, diskettes and documents) this does not include software licenses that are purchased in conjunction with the media. Agencies may order the Media directly from vendor.

For Non-Standard Software please use commodity code: **92007a**.

***** NOTE *** Software licenses DO NOT include installation software or manuals. Both must be ordered separately. Most of the knowledge needed to make decisions on purchases will have to come from the schools or I/T professional serving it rather than from the Office of Procurement Management. Software Houser International can also answer general software selection questions.**

Microsoft client access licenses (CAL), will have to be acquired for all networked computers.

The pricing from Microsoft has changed so that workstations, which are on a network, will need to have client licenses to be able to legally communicate with the server. Those doing the purchasing **must** know what client licenses are already purchased, if any, and at what workstations.

Below are some of the unique requirements of the new contract.

- OS – Operating Systems License
- SERVER – Server Licenses
- APPS – Applications Software Licenses
- DISC & DOCS – Media and Documentation
